(57) **CLAIM**

I claim the ornamental design for the low profile preamplifier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the low profile preamplifier. FIG. 2 is a top view of the low profile preamplifier of FIG. 1. FIG. 3 is a right-side view of the low profile preamplifier of FIG. 1.

FIG. 4 is a left-side view of the low profile preamplifier of FIG. 1.

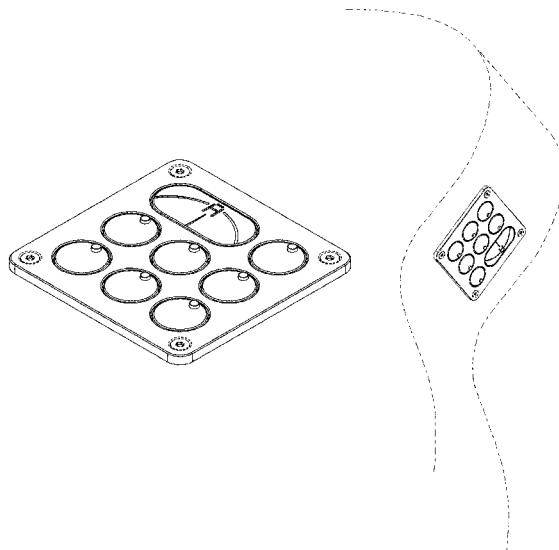
FIG. 5 is a front view of the low profile preamplifier of FIG. 1.

FIG. 6 is a back view of the low profile preamplifier of FIG. 1. FIG. 7 is an environmental view of the low profile preamplifier of FIG. 1 that shows a position of use on a guitar.

A back view of the low profile preamplifier is not shown because the back forms no part of the claimed design.

In the figures, features of the low profile preamplifier drawn in broken lines form no part of the claimed design. In FIG. 7, a guitar body is shown in broken lines as environment forming no part of the claimed design.

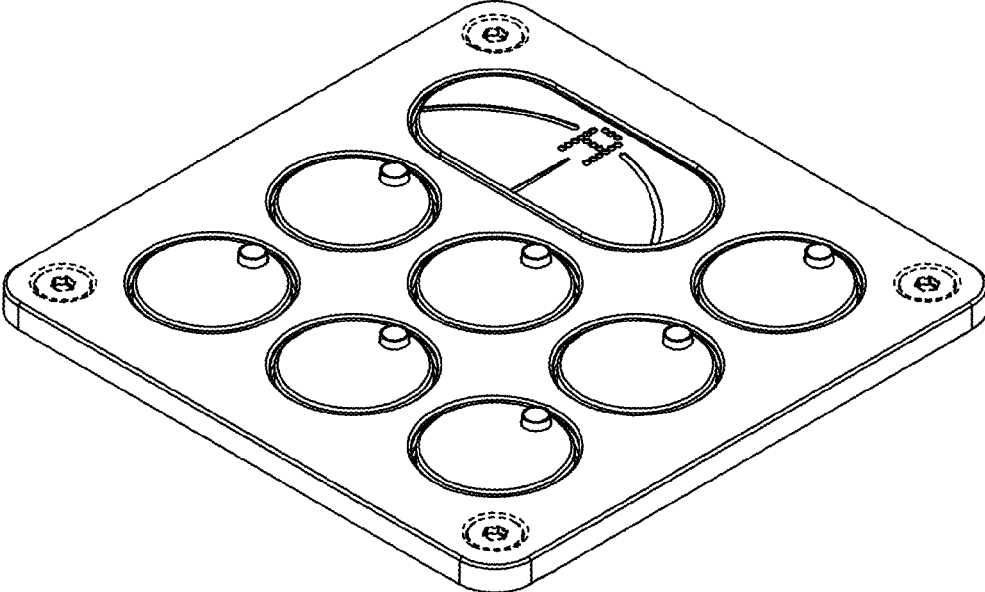

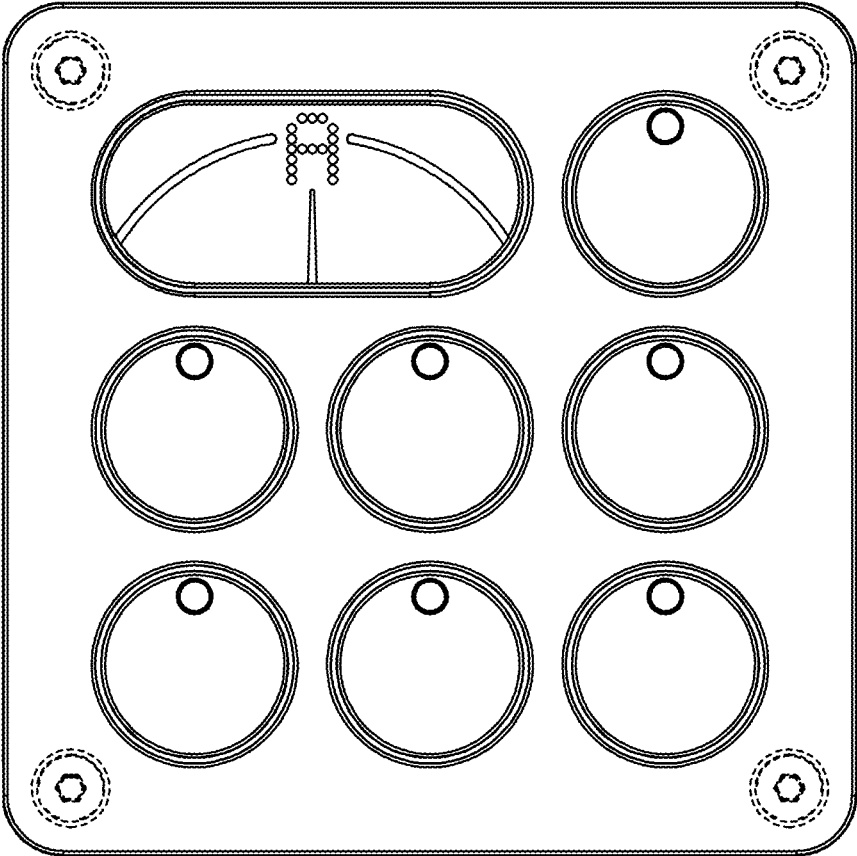

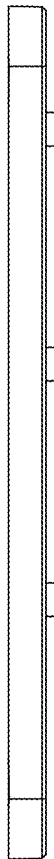

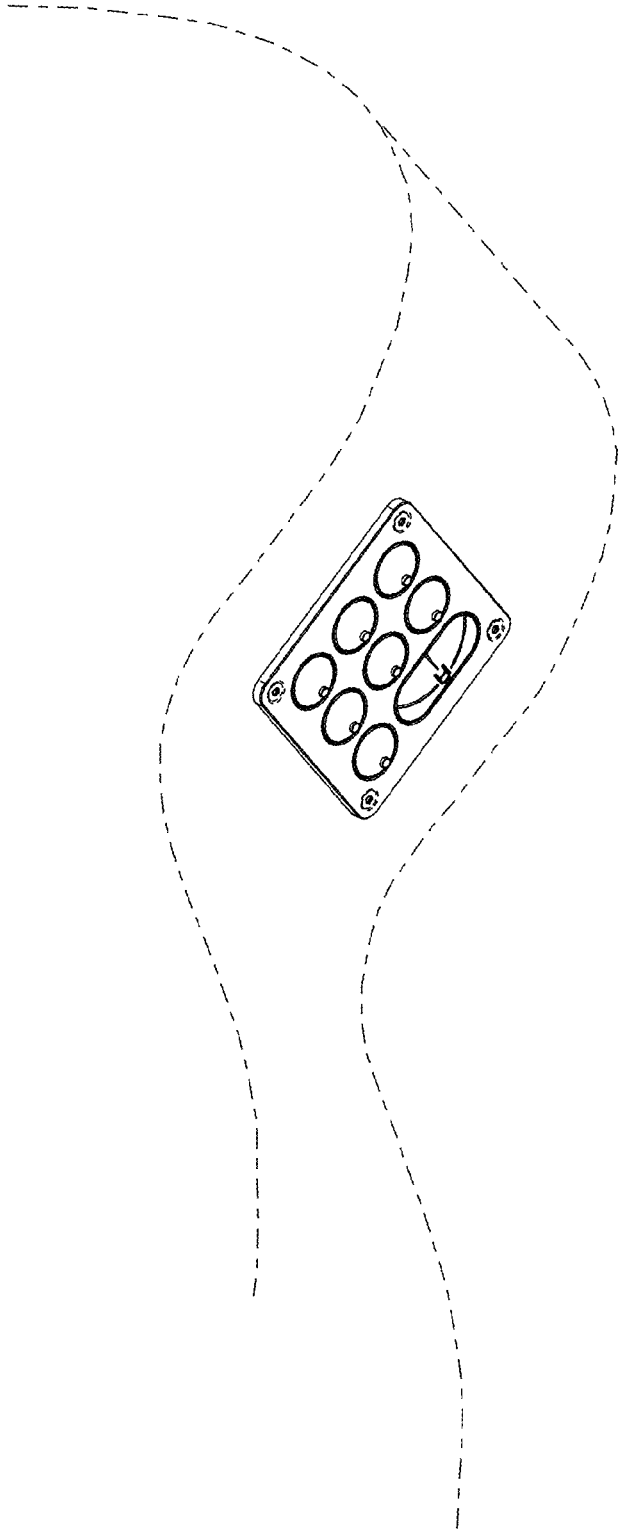
