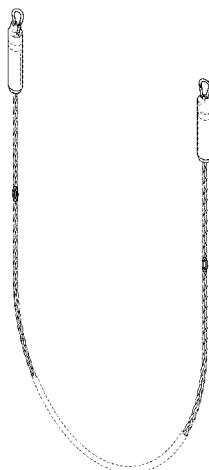


FIG. 7 is a bottom view of the exercise training jump rope of FIG. 1.

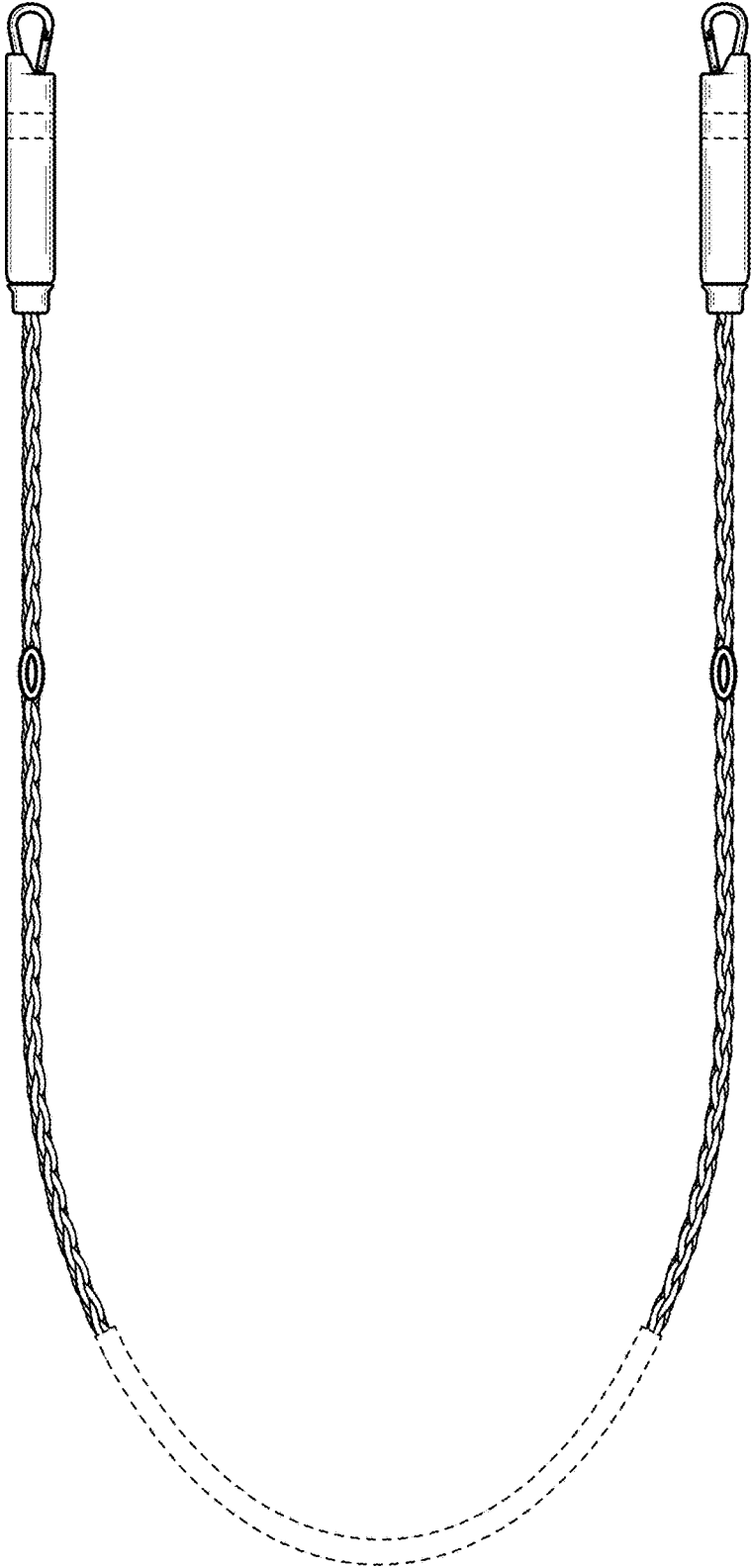

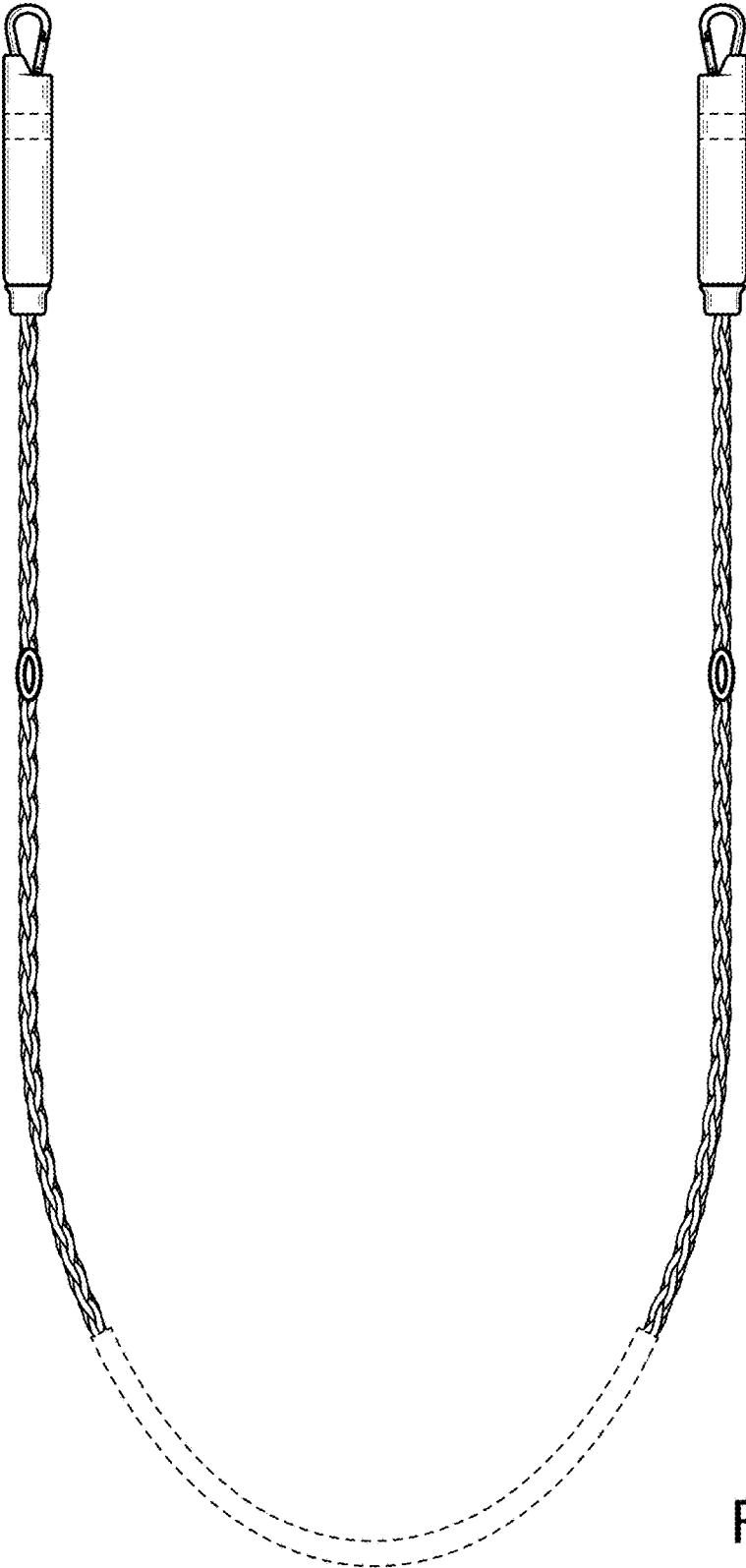

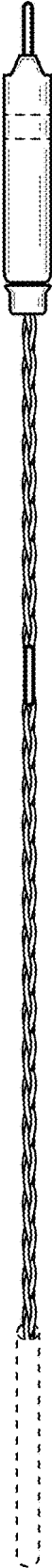

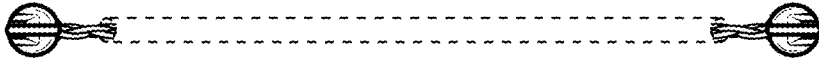

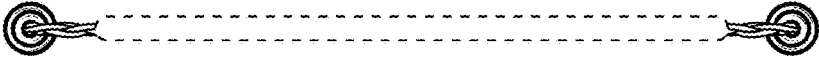
