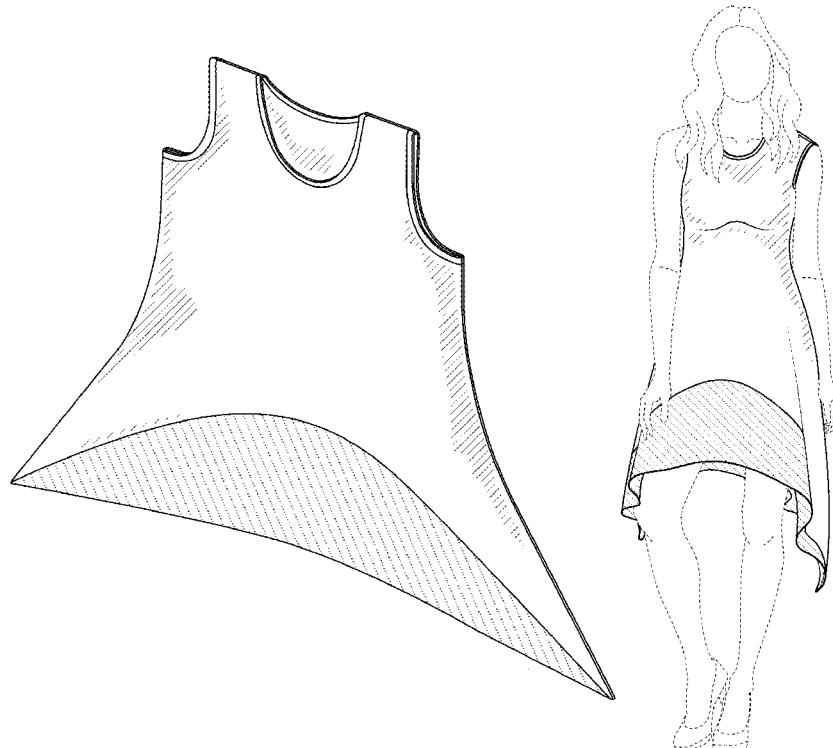
(57) **CLAIM**

The ornamental design for a “dress”, as shown and described.

DESCRIPTION

FIG. 1. is perspective view of the dress;
FIG. 2 is a front view of the dress of FIG. 1;
FIG. 3 is a back view of the dress of FIG. 1;
FIG. 4 is a top view of the dress of FIG. 1;
FIG. 5 is a bottom view of the dress of FIG. 1;
FIG. 6 is a side view of the dress from the right of FIG. 1;
FIG. 7 is a side view of the dress from the left of FIG. 1; and,
FIG. 8 is an environmental view of the dress worn by a person.
The large broken lines in FIG. 8 depict environment and form no part of the claimed design. The smaller dotted lines illustrate unclaimed surface features and designs.

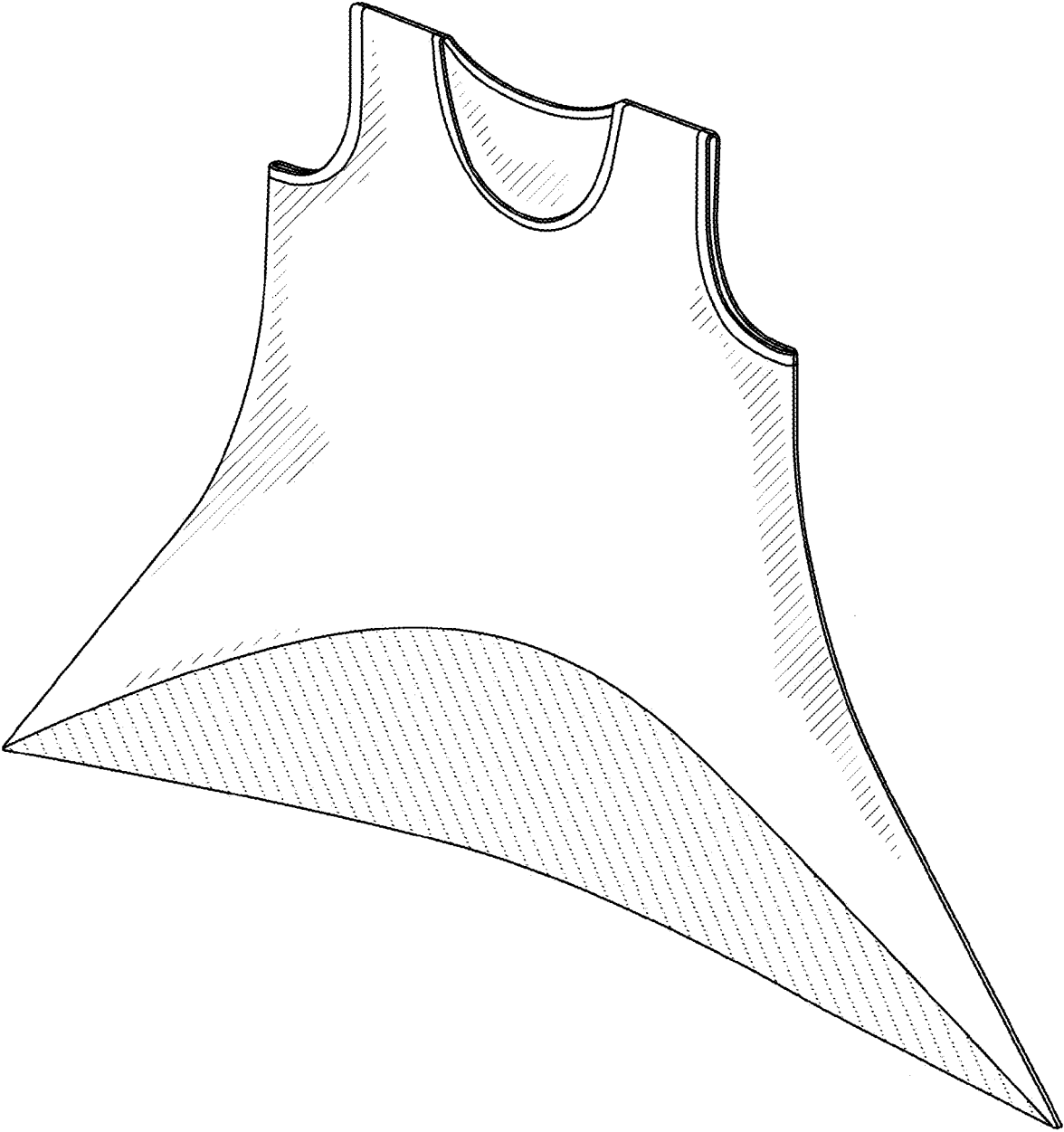

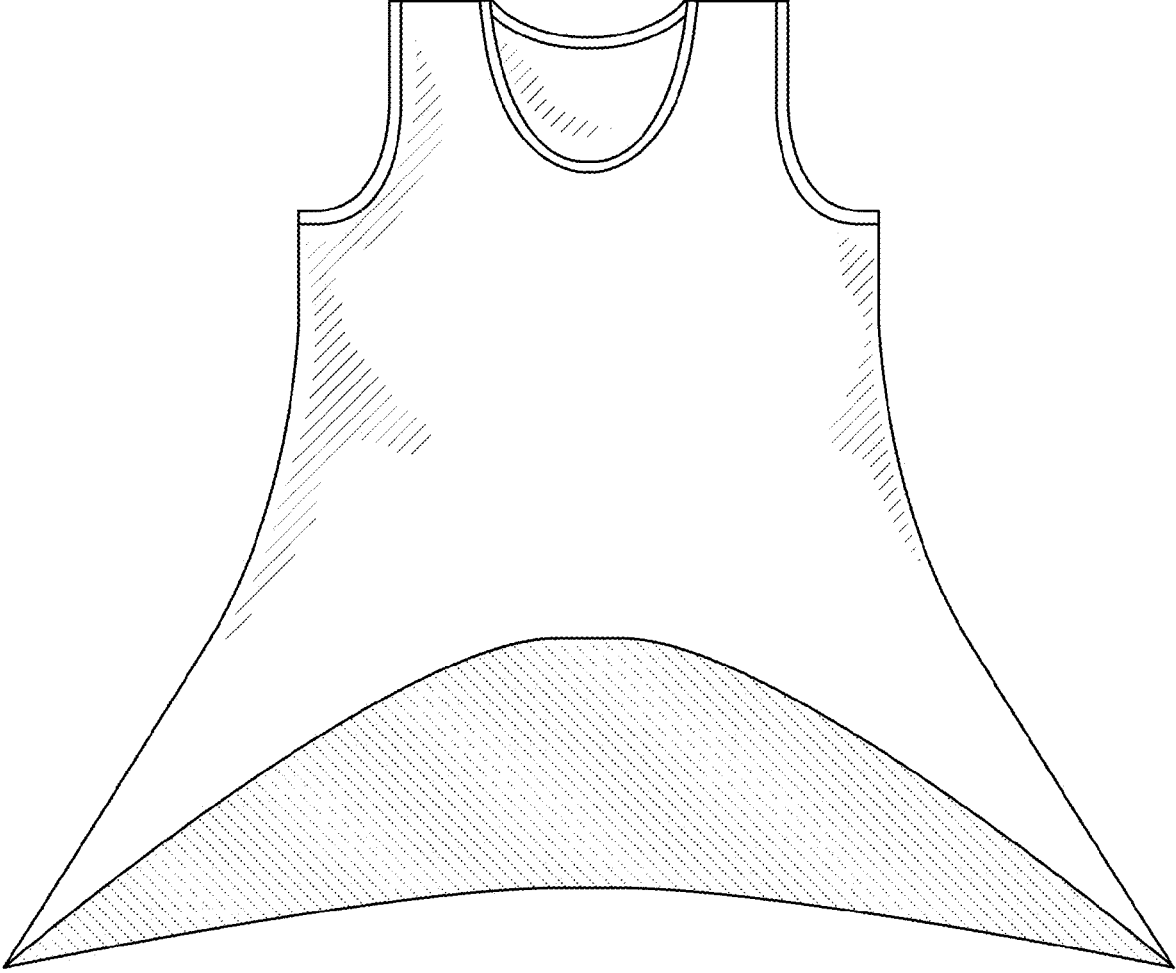

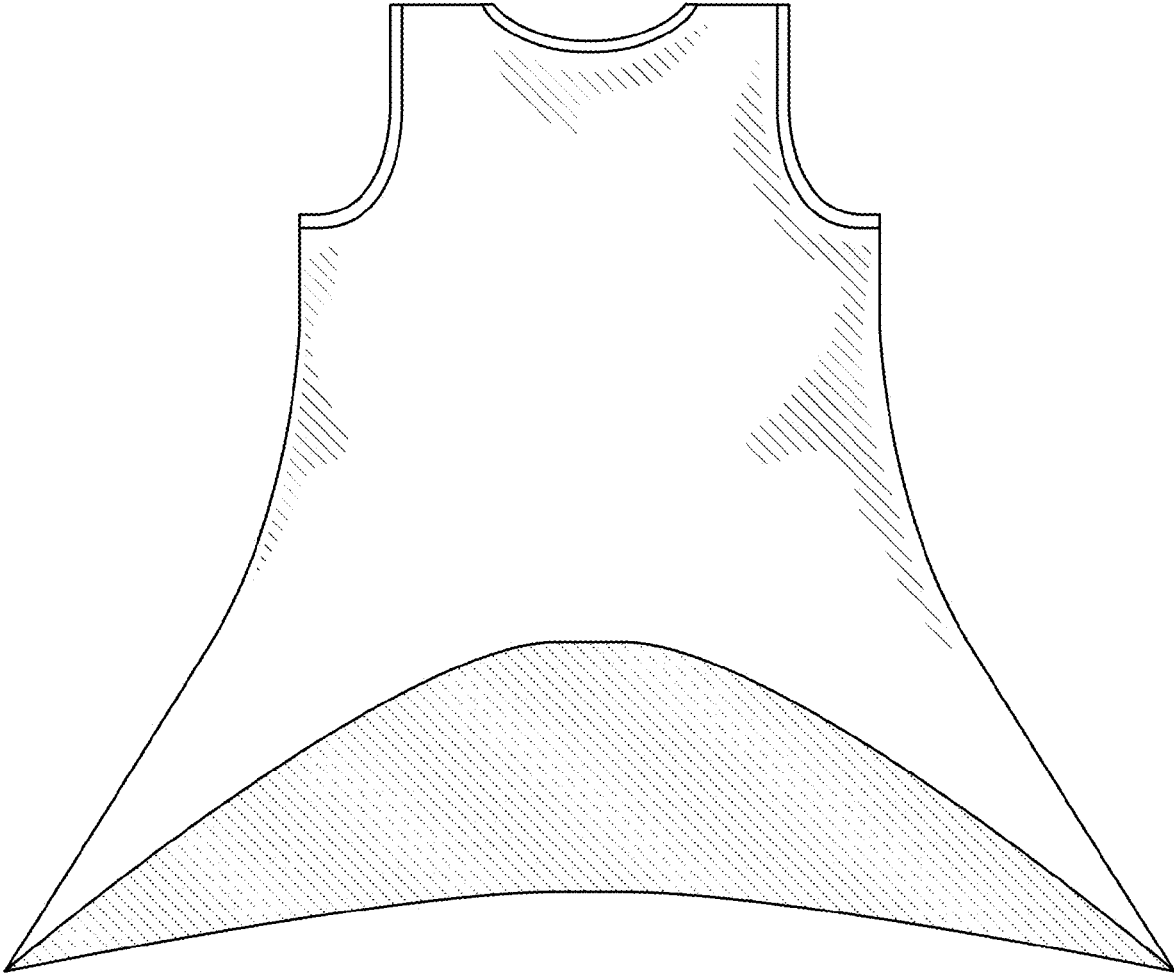

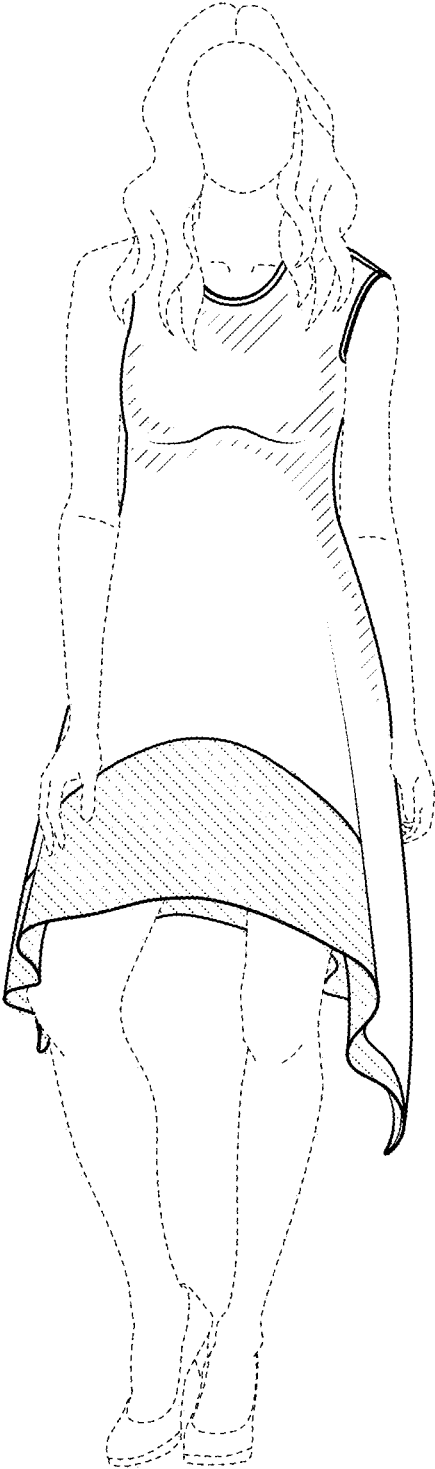
